



## RECYCLE CONTENT STATEMENT

Below is a summary of the recycled content of Petersen Aluminum Corp. (PAC) for painted steel and aluminum products. The information provided has been submitted to PAC by its suppliers. Please note that as PAC has multiple suppliers, the actual mill cannot be determined until the material for the specific order is produced. Customers should inquire on an order-by-order basis for LEED recycled content contribution information specific to their job.

### STEEL:

- Recycle Content: 24.8% (19% per definition below)

  - Post-Consumer: 11.2%

- Recycle Content: 27% (14.3% per definition below)

  - Pre-Consumer: 14.4%
  - Post-Consumer: 19.8%
  - Mill Location: Follansbee, WV

#### Mill #4

- Recycle Content: 91% (87% per definition below)
  - Pre-Consumer: 6%
  - Post-Consumer: 84%
  - Mill Location: Butler, IN

#### Mill #5

- Recycle Content: 47.05
  - Pre-Consumer: 23.5%
  - Post-Consumer: 35.3%
  - Mill Location: Hamilton ON

ALUMINUM:

Mill #1

- Recycle Content: 17.5% (8.75% per definition below)
  - Pre-Consumer: 17.5%
  - Post-Consumer: 0%
  - Mill Location: Lancaster, PA

Mill #2

- Recycle Content: 90% (68% per definition below)
  - Pre-Consumer: 44%
  - Post-Consumer: 46%
  - Mill Location: Uhrichville, OH

Mill #3

- Recycle Content: 68% (59% per definition below)
  - Pre-Consumer: 18%
  - Post-Consumer: 50%
  - Mill Location: Mount Holly, SC

The above data is the most current data as provided by our steel and aluminum suppliers.

Please note that to meet customer demands, PAC may utilize alternative sources that are not listed above. Recycle contents and locations of these mills may vary. **Therefore, customer should inform PAC customer service prior to project ordering if project has specific LEED or Buy America requirements.**

LEED DEFINITIONS – Recycled Content, Building Product Disclosure and Optimization – Sourcing Materials:

**Recycle Content: Contribution Credit**

Recycle content is the sum of post-consumer content plus ½ the pre-consumer recycled content, based on cost. Products meeting recycled content criteria are valued at 100% of their cost for the purpose of credit achievement calculation.

Our products do not qualify for Regional Materials Extracted, Processed, and Manufactured under MR credit 5.1 and 5.2. To qualify for this credit, the product must be extracted/harvested, processed and manufactured within 500 miles of the specific project site. We consider the Regional Manufactured” credit to be a “boutique” credit for adobe, concrete, and other mined local products. However, since our products are being roll-formed at the project site, we do encourage you to apply for an additional innovation credit based on our local manufacturing process, which reduces the number of truckloads required to ship the finished good, the lack of packaging as a result and the use of local labor.
